- Assessor Travel: Most site visits will be conducted virtually. This will require the project team walking the site while the Green Globes Assessor is on video. There are a few complex project types that will still require an in person assessor site visit (i.e. data centers, large hospitals, and laboratories etc.) This will be determined when a quote is presented. If an in person site visit is required or requested a \$2,000 travel stipend for contiguous US will be charged. A higher cost will be evaluated for projects outside of the contiguous U.S. Reviewed on a case by case basis.
- **Volume Pricing:** Please contact GBI directly regarding volume pricing for more than 6 assessments.
- Recognition Items (Optional through our third-party vendor <u>American Diversity</u>)
 - Decal: \$175
 - Indoor/Outdoor Plaques: \$600 \$1,500
- **Expedite Fees**: \$6,000 per assessment.

Expediting time frame:

- NC minimum 45 days after order, payment, survey and documents ready for review
- EB minimum 30 days after order, payment, survey and documents ready for review
- Report delivery is 1-2 weeks vs. 4-6 weeks for standard orders after the site visitors last delivery of documentation whichever is later.
- **Complexity Fees** = \$1,750 to \$5,000 based upon the complexity of the project and gross square feet. Complexity fees: additional time allotted for the assessor to assess the project based upon the complexity or multiple building space types. Buildings that would fit into this







category: hospitals, labs, buildings with labs, energy production facilities, manufacturing plants, 24-hour inpatient care facilities, buildings with 4 or more space types. GBI staff will notify you prior to quote development if a complexity fee may be necessary.

■ **Green Globes Consultants:** Green Globes Professionals (GGPs) can cost-effectively work with your team to assemble your documentation and complete your Green Globes survey in preparation for review by your assigned Green Globes Assessor (GGA).*
